Common Errors

- You can submit a maximum of 20 CEUs per cycle. If an event would put you over 20 CEUs, reduce the hours you are submitting so that you end with exactly 20.
- You can submit a maximum of five tier-2 CEUs and five tier-3 CEUs per cycle. The website will prevent you from adding more than the limit.
- Apple's Safari web browser seems to have trouble with this submission form. Consider using Mozilla Firefox or Google Chrome to submit your CEUs.
